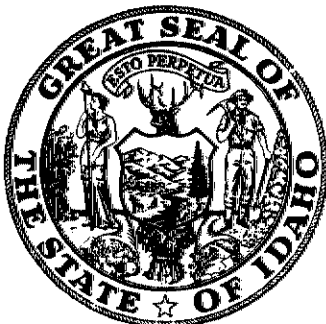

ARTICLES OF INCORPORATION  
OF  
COEUR D'ALENE RIVER CAMPGROUND, INC.

ARTICLE I.

The name of the Corporation shall be Coeur d'Alene River Campground, Inc.

ARTICLE II.

The period of duration shall be perpetual.

ARTICLE III.

The purposes for which the Corporation is organized shall be conducting the business of commercial or recreational camping, and shall include the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

ARTICLE IV.

The aggregate number of shares of which the Corporation shall have authority to issue shall be ten thousand (10,000) shares of common stock, without nominal or par value.

ARTICLE V.

The internal affairs of the Corporation shall be governed by the duly-adopted bylaws of the Corporation.

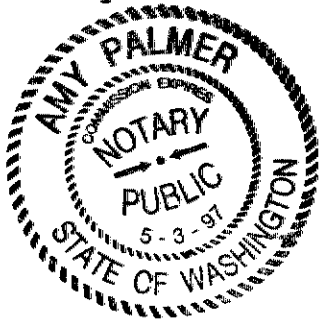
