## ARTICLES OF INCORPORATION

OF

## CAPITOL AERO CLUB INC.

KNOWN ALL MEN BY THESE PRESENTS:

That we, the undersigned, all being of full age and citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a non-profit cooperative association under the laws of Idaho, Title 30, Section 1001-1006, to be hereinafter referred to as a corporation.

And we hereby certify in writing:

I

That the name of said corporation shall be CAPITOL AERO CLUB INC.

II

That the purpose for which said corporation is formed are:

- (1) To encourage and further the interest in aviation among private citizens.
- (2) To provide educational requirements and facilities to allow members to qualify for Civil Pilot ratings and certificates.
  - (3) To fly for personal enjoyment or benefit.
- (4) To buy, sell, lease and mortgage airplanes, and parts that are necessary for the operation of the corporation.
  - (5) To give instructions and training in the art of flying.

III

The existence of this Corporation shall be perpetual.

IV

The registered office of this Corporation shall be:

This corporation does not have and shall not have any capital stock, and neither shall it issue to its members certificates representing capital stock, and this corporation shall not be operated for a pecuniary profit.

AI

The rights and interests of all members shall be equal, and no member can have or acquire a greater interest therein than any other member.

VI

The Corporation will issue membership certificates to each member as set forth in the by-laws, which certificates cannot be assigned. A person can only become a member by resolution of the Board of Directors as prescribed by the by-laws.

The rights of Membership will be extended to all persons, subject to acceptance by the Board of Directors and upon payment of membership fees, dues and other assessments borne equally by all members.
