ARTICLES OF INCORPORATION

OF

Know All Men By These Presents, That we, the undersighed, all of whom are citizens of the United States and of the State of Idaho and over the age of twenty-one years, do hereby associate ourselves together to form a non-profit cooperative association under and pursuant to Chapter 10, Title 29, Idaho Code Annotated, and we do hereby certify as follows;

I.

The name of this association is the "LATIGO RIDERS CLUB Inc."

The purpose and objects of the association are, without pecuiary profit, to promote, conduct, provide for, maintain and carry on any and all kinds of activities for the entertainment, diversion, and recreation of the members of the association, and to that end to buy, sell, hold, acquire, own mortgage, hypthecate, convey, transfer, lease, exchange, trade, and dispose of real and personal property.

To do all acts permitted by said Chapter 16 of Title 29, Idaho code annotated, as it now exists or as it may be hereafter amended, and all such other acts as are necessary and expedient to accomplish its stated purposes.
