ARTICLES OF INCORPORATION

OF

DETTLOFF ENTERPRISES, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

Ι

The name of the Corporation is Dettloff Enterprises, Inc.

ΤT

The period of its duration is perpetual.

III

The purpose or purposes for which the corporation is organized are: all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, § 30-1-3.

ΙV

The aggregate number of shares which the corporation shall have authority to issue is One Thousand Shares of No par value common stock.

V

Shareholders have preemptive rights.

VT

Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the By-Laws of the corporation, including provision for restriction on transfer of shares, as provided in Idaho Business Corporation Act, § 30-1-23A.

VII
