

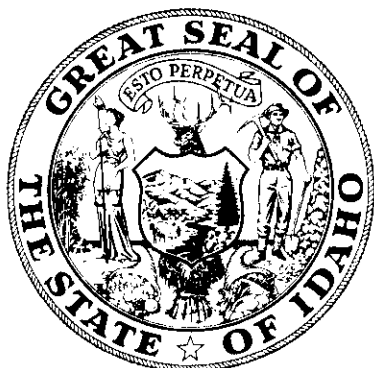

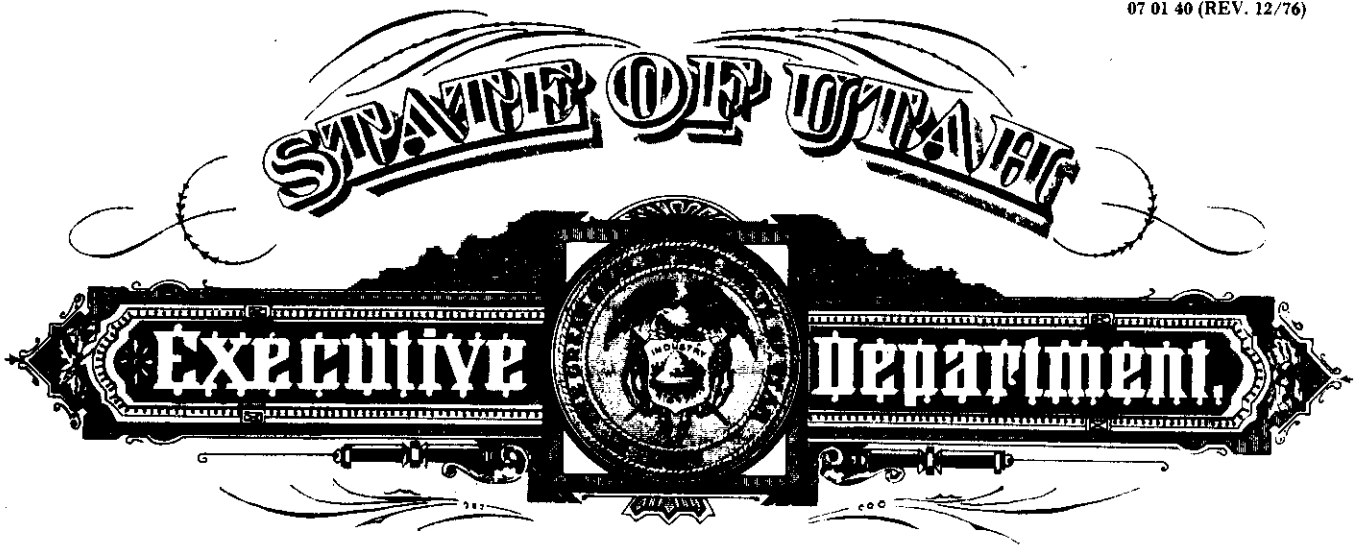

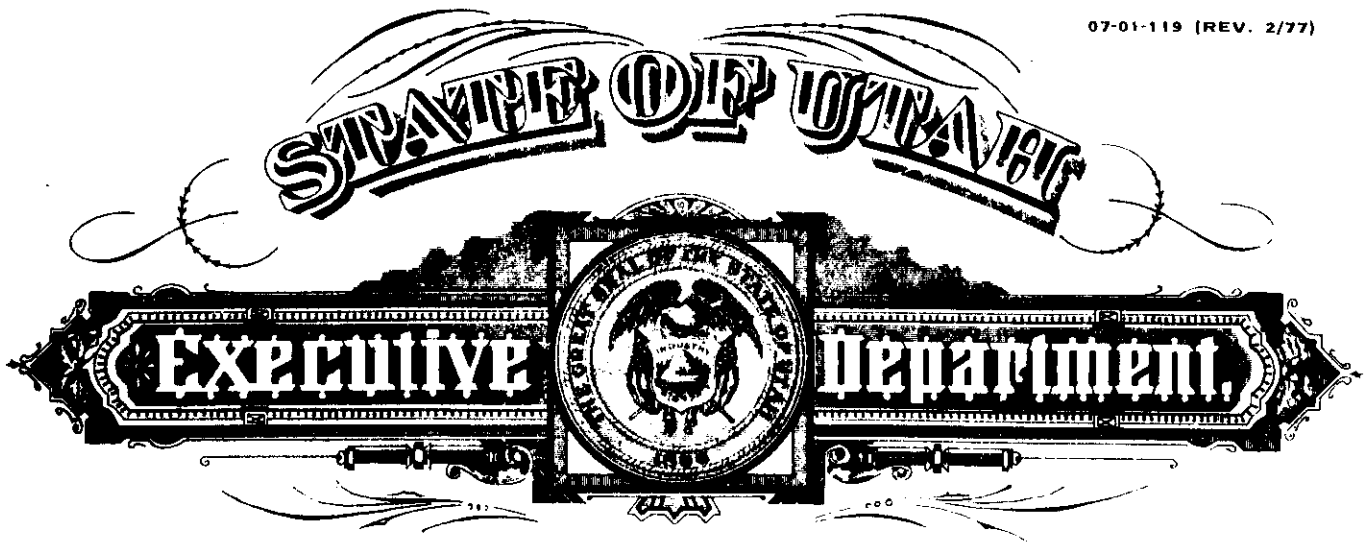

## ARTICLES OF INCORPORATION

OF

SCOFAM CORPORATION

69097

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of the corporation pursuant to the Utah Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

### ARTICLE I.

NAME: The name of the corporation (hereinafter called the "Corporation") is SCOFAM CORPORATION.

### ARTICLE II.

DURATION: The duration of the Corporation shall be perpetual.

### ARTICLE III.

PURPOSES: The purposes for which the corporation is organized are to engage in:

1. The operation, management and development of a mobile home park.
2. The sale, lease, rental, purchase, supply or development of services and/or property, both real and personal, as is lawful, and such other business activity as is lawful pursuant to the applicable statutes of the State of Utah.

### ARTICLE IV.

POWERS: The corporation shall have such powers as are enumerated in Section 16-10-4 of the Utah Business Corporation Act, and such other

powers not specifically enumerated therein, but otherwise permitted by law and necessary and proper in furtherance of Corporation's purposes enumerated above.

#### ARTICLE V.

AUTHORIZED CAPITAL: The aggregate number of shares which the Corporation shall have authority to issue is one million (1,000,000) shares, and the par value of each such share shall be ten cents (\$.10). All such shares shall be common shares having identical rights and privileges; the holder of such shares shall not have pre-emptive rights to acquire unissued shares of the Corporation nor shall holders of such shares have cumulative voting rights.

#### ARTICLE VI.

COMMENCEMENT OF BUSINESS: The Corporation shall not commence business until it has received consideration of the value of at least One Thousand Dollars (\$1,000.00) for the issuance of its shares.

#### ARTICLE VII.

RIGHT OF CORPORATION TO ACQUIRE AND DISPOSE OF ITS OWN SHARES: The Corporation shall have the right to purchase, take, receive or otherwise acquire, hold, own, pledge or otherwise dispose of its own shares, but purchase of its own shares, whether direct or indirect, shall be made only to the extent of unreserved and unrestricted earned surplus and unreserved and unrestricted capital surplus available therefore.

#### ARTICLE VIII.

INITIAL REGISTERED OFFICE AND AGENT: The address of the initial registered office shall be 2561 East 2940 South, Salt Lake City, Utah 84109, and the name of the initial registered agent at such address is John F. Scott.

#### ARTICLE IX.

DIRECTORS: The number of directors constituting the initial board of directors shall be four (4), and the names and addresses of the persons who shall serve as the directors until the first annual meeting of shareholders or until their successors are elected and qualified are:

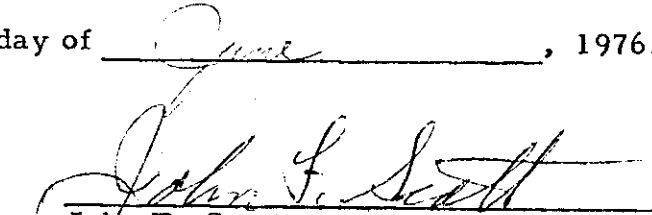

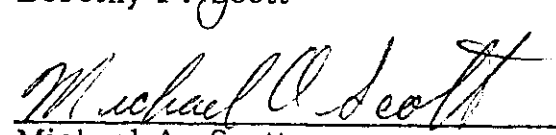

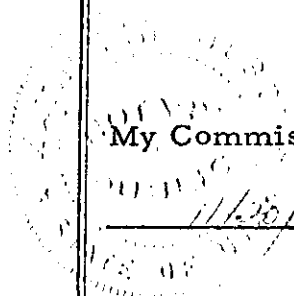
