We, the undersigned, natural persons of the age of 21 years or more, acting as incorporators of a corporation under the Utah Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is S. B. & E. TRANSPORTATION COMPANY.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

- a. To engage in operations as a motor carrier of passengers and/or property for hire, in intra and interstate commerce.
- b. To engage in the business of making investments in real and personal properties of any and all kinds and types.
- c. To engage in any and all other business permitted to a corporation by the laws of the State of Utah.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 50,000 shares of no par value.
