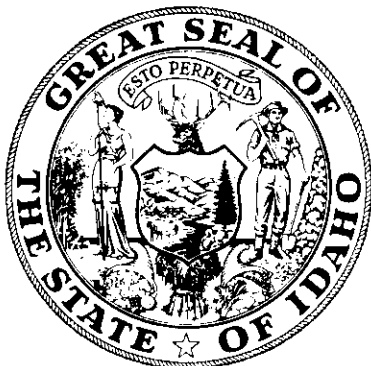

ARTICLES OF INCORPORATION

of

S. B. & E. TRANSPORTATION COMPANY #109499

We, the undersigned, natural persons of the age of 21 years or more, acting as incorporators of a corporation under the Utah Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is S. B. & E. TRANSPORTATION COMPANY.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

a. To engage in operations as a motor carrier of passengers and/or property for hire, in intra and interstate commerce.

b. To engage in the business of making investments in real and personal properties of any and all kinds and types.

c. To engage in any and all other business permitted to a corporation by the laws of the State of Utah.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 50,000 shares of no par value.

FIFTH: The corporation will not commence business until a consideration of a value of at least One Thousand Dollars (\$1,000.00) has been received for the issuance of shares.

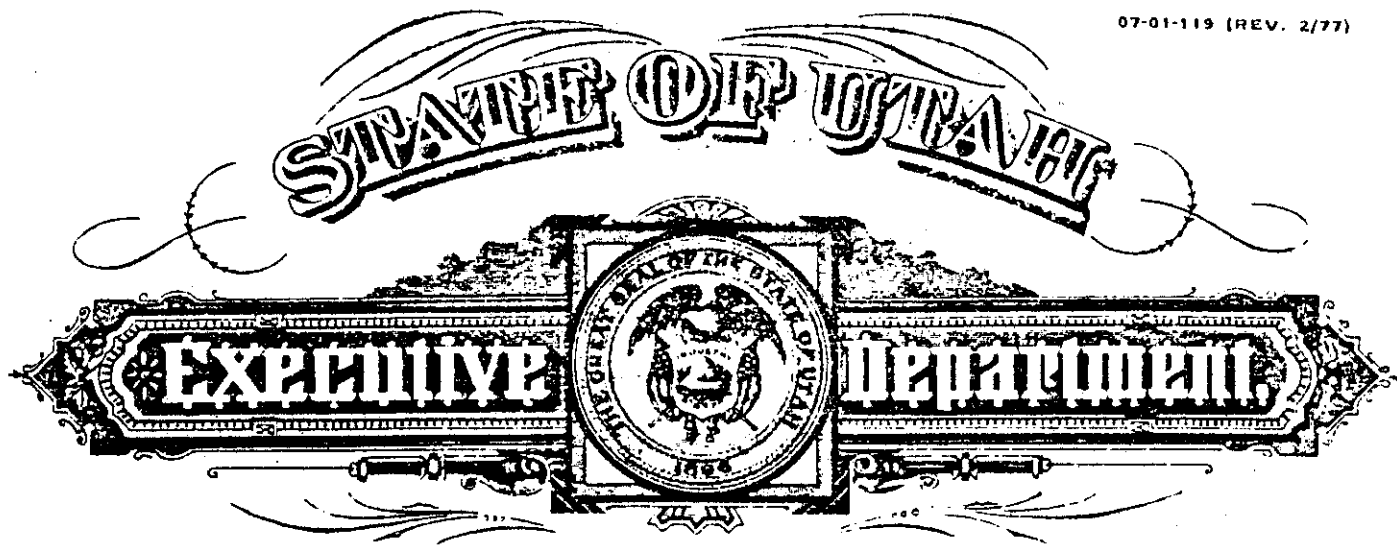
