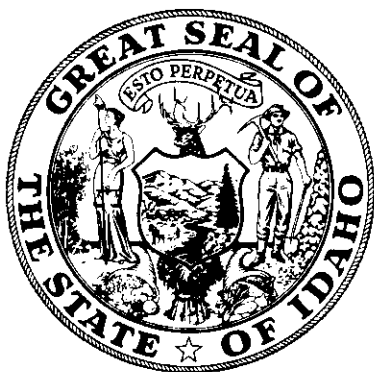

ARTICLES OF INCORPORATION

OF

PEOPLE FOR A PROGRESSIVE POCATELLO, INC. 04

The undersigned, acting as incorporators of a corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation;

1. NAME: The name of the corporation is PEOPLE FOR A PROGRESSIVE POCATELLO, INC.

2. NON-PROFIT: This is a non-profit corporation.

3. DURATION: The period of the corporation is perpetual.

4. PURPOSES: The purpose or purposes for which the corporation is organized is to promote organization of a non-partisan citizen's group to promote issues of public concern by communicating with various public officials and governmental entities on issues of public interest and concern, and for the transaction of any or all lawful business for which non-profit corporations may be incorporated under the Idaho Business Corporation Act.

5. MEMBERSHIP: This corporation is to have voting members. The rights, duties, obligations, and qualifications of members shall be as prescribed by By-Laws to be subsequently adopted.
