ARTICLES OF INCORPORATION

1. The name of the Body incorporated herewith shall be the Hailey Firefighter's Association, Inc.
 2. The Hailey Firefighter's Association is hereby declared to be a non-profit, eleemosynary corporation. Said corporation shall have not be associated with any activity by any person which is conducted solely for personal profit or personal gain. Said corporation is organized and operating under the Idaho Nonprofit Corporation Act, Section 30 - 301 et seq., Idaho Code.
 3. The Hailey Firefighter's Association is hereby incorporated in perpetuity. If for any reason the Hailey Firefighter's Association should ever become unincorporated, the assets and liabilities of the Association shall be liquidated, and said monies shall be distributed to non-profit or charitable organizations as determined by the Hailey Fire Chief.
 4. The Hailey Firefighter's Association is hereby incorporated for the purpose of controlling monies raised by the Association. The disbursement of said monies shall be wholly at the discretion of the membership, and is intended for the purchase of needed equipment and supplies, the provision of training opportunities, the financial relief of persons suffering loss, the assistance of members in crisis situations, and the entertainment and recreation uses of the members of the Association as a whole.
 5. The management of the affairs of the Association is wholly vested in the membership of the association as determined through Association by-laws. The membership may determine through a majority vote to appoint an executive body to the association. The responsibility and authority given the Executive body shall be as determined in the Hailey Firefighter's Association's by-laws.
 6. The affairs, practices, composition and structure of the Hailey Firefighter's Association shall be as determined in the Association by-laws.
