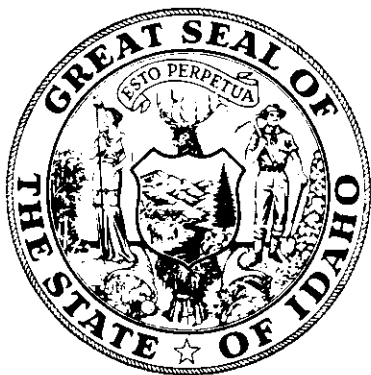

Article Three: The notice required by Section 30-1-87, Idaho Code, was given on the 15th day of October, 1990.


Article Four: All debts, obligations and liabilities of the corporation have been paid and discharged.
