That we, the undersigned, being natural persons, of full age and citizenship of the United States and of the State of Idaho, in order to form a corporation for the purposes hereinafter stated, pursuant to the statutes of the State of Idaho, do hereby certify as follows:

I

That the name of the corporation is HENDERSON'S DAD & LAD, INC.

The purpose for which said corporation is formed is to engage in the merchandising of clothing, the buying and selling of clothing and any and all allied businesses that may be in any way connected with the merchandising of clothing.
