


ARTICLES OF AMENDMENT

The undersigned, being the President and a majority of the Shareholders of Brady & McDaniel, Chartered, a corporation organized under the laws of the State of Idaho, do hereby adopt the following amendment to the Articles of Incorporation of Brady, McDaniel and Matthews, Chartered:

1. Change the name of the corporation from Brady & McDaniel, Chartered to: BRADY, SAETRUM, TINGEY, DAY & JOYCE, CHARTERED, effective July 1, 1987.

The undersigned further represent that the total number of issued shares in said corporation is the sum of 3,000 shares, with 1,500 shares outstanding and entitled to vote with - 1,498 shares belonging to Michael G. Brady, 1 share belonging to Rodney R. Saetrum, and 1 share belonging to Joel E. Tingey - by a majority vote of 1,500 shares, the above specified amendment is hereby adopted. Such amendment provides for no exchange, reclassification, or cancellation of issued shares nor does it effect a change in the amount of stated capital pursuant to Idaho Code, §30-1-61.






