

ARTICLES OF INCORPORATION.

OF "THE WIGGETT & EMPEY COMPANY, (Limited)

Know all MEN by these Presents; That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the State of Idaho, And we hereby further certify:

FIRST:- That the name of said Corporation is "The Wiggett and Empey Company" (Limited).

SECOND:- That the purposes for which it is formed, are to carry on the General Mercantile and Trading Business , and buy and sell goods and personal property of every kind and nature for cash and for credit, and do any and all things pertaining to such business, in the County of Kootenai State of Idaho.

~~THIRD:- That the place where its principal place of business is to be transacted, shall be at the town of Coeur d'Alene, Kootenai County Idaho.~~

~~FOURTH:- That the term for which it is to exist is twenty-five years from the date of Incorporation.~~

FIFTH:- That the number of its Directors shall be five, and that the residences and names of those who are appointed for the first year are as follows:

SEVENTH:- That the amount of said Capital Stock which has been actually subscribed, is Fifty Thousand Dollars. (\$50,000.) and the following are the names of the persons by whom the same has been subscribed, to-wit:-

That the said Stock has been paid up by personal property, goods and credits, to the extent of *one third of* the par value of said Stock, which property is hereby turned over to said Corporation, and the said Stockholders hereby limit their separate several liability only to the unpaid portion of their stock subscribed, and hereby incorporate under the provisions of the General Incorporation Act of the State of Idaho, as well as of the Amendment of March 11th. 1891, to Section 2609 of the Revised Statutes of Idaho, laws of 1891, pages 172-3-4.
