That C.E.Runacres of Shelton Washington, Anna Runacres of Shelton Washington, and G.Kirkwood of New Meadows Idaho, desirous of forming a Corporation under the laws of the state of Idaho, and to end do hereby certify:

# (First)

That the name assumed by the said corporation, and by Which it shall be known if the MEABOWS LUMBER COMPANY:

# (Second)

That the purpose for which said corporation is formed, is to buy, sell, operate, lease, saw-mills, and other manufacturing plants, for the manufacture, sale and distribution of lumber and lumber products of all kinds, and timber and timber products of all kinds or nature, to buy sell, manufacture timber and timber products, to buy and sell timber and timber lands to acquire saw logs, and to manufacture the same into sawed lumber and other timber products, to own and operate logging equipment and machinery, to manufacture boxes and other timber products, to own and operate, dry kilns, lumber yards, to buy and sell, saw logs, lumber and timber products of all kinds and nature, to maintain, lumber yards, in fact to carry on a general business for the manufacture of lumber and timber products and the sale of the same, either wholesale or retail, and to own and acquire such real estate, as shall be necessary to carr, out the object hereof, to own and operate such commisaries, as shall be necessary or convenient, and to purchase merchandise and supplies and to sell the same in the ordinary course of trade.
