#### ARTICLES OF INCORPORATION

## KINGSTON TELEVISION, INCORPORATED

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify;

#### ARTICLE I.

#### NAME OF ASSOCIATION

The corporate name of this organization shall be "KINGSTON TELE-VISION, INCORPORATED."

#### ARTICLE II.

#### PURPOSES

The purposes and objects for which said corporation is formed are as follows:

- (a) To form a private, non-profit corporation.
- (b) To organize a limited number of residents in the Kingston area, of Shoshone County, State of Idaho, to erect, equip, and operate a television antenna distributing system.
- (c) To buy, own, sell, mortgage, hold, or otherwise hypothecate both real and personal property as the occasion and necessity may demand, by good business practice for the operation of such a television signal distribution system.
- (d) To hire, fire, or otherwise employ agents, council, or any other employees as may in the opinion of the Board of Directors of this corporation, be pertinent and necessary to the operations of the business.
- (e) To have and exercise all powers granted to non-profit corporations under the laws of the State of Idaho.

#### ARTICLE III.

This corporation shall have a perpetual existence unless sooner dissolved by a unanimous vote of the membership.
