#### KNOW ALL MEN BY THESE PRESENTS:

That We, Jeffrey A. Sadler, 795 Riverheights Drive, Meridian, Idaho 83642, and Jeanne Belfy, 1205 Ranch Road, Boise, Idaho, 83702, pursuant to the authority contained in Title 30, Chapter 3, Idaho Code, do hereby declare, certify and adopt the following Articles of Incorporation:

## ARTICLE I

The name of the corporation is the BOISE CHAMBER MUSIC SOCIETY, It is a corporation not organized for profit. The period of duration is perpetual.

#### ARTICLE II

The corporation is organized exclusively for educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. More particularly, the corporation is organized to promote the understanding, enjoyment and appreciation of chamber music throughout Idaho's Treasure Valley, through such means as the sponsorship of chamber music performances, lectures, program notes, and gatherings to meet chamber music performers.

#### ARTICLE III

Management of the affairs of the corporation shall be vested in a board of directors, which board shall be self perpetuating by the reelection and replacement of board members within such terms as may be provided by the corporate by-laws.

### ARTICLE IV

The street address of the initial registered office of the corporation shall be 795 Riverheights Drive, Meridian, Idaho

83642. The name of its initial registered agent at such street address shall be Jeffrey R. Sadler.
