ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporators of a corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation:

The corporation is formed for non-profit NON-PROFIT: purposes.

ARTICLE III

The period of its duration is perpetual. DURATION:

ARTICLE IV

The purposes for which the corporation is PURPOSES: 17 organized are:

- To conduct and carry on benevolent, charitable, civic and educational activities by promoting the means and opportunities for the education and enjoyment of the public; and to do all and every thing necessary, suitable, and proper for the attainment of any of the purposes hereinabove set forth, all within the meaning of 21 Section 501(c)(3) of the Internal Revenue Code, corporation shall not carry on any other activities not permitted to 22 be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code.
 - This corporation shall have and may exercise such powers as may be conferred upon a non-profit corporation by the laws

1|of the State of Idaho, and as may be necessary and expedient for the administration of the affairs and attainment of the purposes of this corporation, provided that in no event shall this corporation engage in activities which are not benevolent, charitable, educational in nature.

All of the properties and assets of this corporation 5 are irrevocably dedicated to benevolent, charitable, No part of the net earnings, properties or educational purposes. assets of this corporation on dissolution or otherwise shall enure to the benefit of any private person or individual or any member or director of this corporation, and on liquidation or dissolution all properties and assets of this corporation, remaining after paying or providing for all debts and obligations shall be distributed and more non-profit funds, foundations, one or **9**paid over to corporations organized and operated exclusively for benevolent, charitable, civic or educational purposes and which are exempt from income taxation under the laws of the State of Idaho and from income taxation under the Internal Revenue laws of the United States of In the event said Board of Directors fail to select such a distributee or if the named distributee is not qualified to accept 13 said distribution, then the property of the corporation shall be distributed to one or more non-profit charitable funds, foundations, functions as stated in the preceding corporations having sentence, and similarly exempt from the designated classes taxation, or to the State of Idaho, or to any political subdivision 16 thereof, for benevolent, charitable, civic or educational purposes, as shall be directed by decree of the District Court of the State of 17 Idaho, in and for the County of Canyon, upon petition filed by any party concerned in the liquidation.

ARTICLE V

This corporation does not have and shall not have STOCK. any capital stock.

ARTICLE VI
