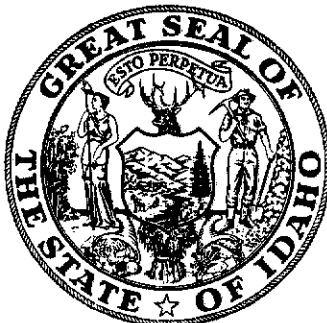

ARTICLES OF INCORPORATION OF GILES TRUCKING, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation shall be **GILES TRUCKING, INC.**

ARTICLE II

The corporation shall have perpetual existence.

ARTICLE III

The purpose or purposes for which the corporation is organized are to carry on the business of commercial trucking services and any lawful activity related to such business, and the transaction of any or all other lawful business for which a corporation may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 100 with par value of \$0.00 per share. The corporation, if appropriate, may authorize and issue shares of preferred or special classes as provided in Idaho Code §30-1-15.

ARTICLE V

There are no provisions denying preemptive rights.

ARTICLE VI

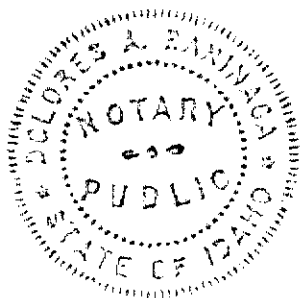
