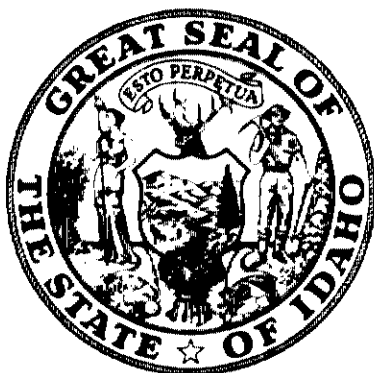

## ARTICLES OF INCORPORATION

OF

### SWAN VALLEY SENIOR CITIZENS, INC.

To further common purposes, the members agree to organize under these Articles of Incorporation.

#### ARTICLE ONE

##### NAME

The name of this organization shall be Swan Valley Senior Citizens, Inc., which in these articles shall be referred to as the "Association."

#### ARTICLE TWO

##### REGISTERED OFFICE

The registered office of the Association shall be at the American Legion Hall, Swan Valley, Bonneville County, Idaho. The Association may have such other offices as may from time to time be designated by its council. The registered agent is Richard S. Cotter.

#### ARTICLE THREE

##### PURPOSES

The purposes of this Association shall be:

1. To promote and effect improved dignity and quality of life for all older residents in the community.
2. To bring needed services to the older residents of the community.
3. To help the community benefit from the resources in knowledge, experience, wisdom, skills, concern, energy and service of its older residents.
4. To do anything necessary and proper for the accomplishment of the purposes stated herein, not inconsistent with the corporation laws of the State of Idaho.

This Association is organized and operated exclusively for the above stated purposes, and for other nonprofit purposes, and no part of any net earnings shall inure to the benefit of any private member.

#### ARTICLE FOUR

##### DURATION

The duration this Association shall be perpetual.

#### ARTICLE FIVE

##### STOCK

The Association shall not issue stock and no dividends or pecuniary profit shall be declared or paid to the members hereof.
