



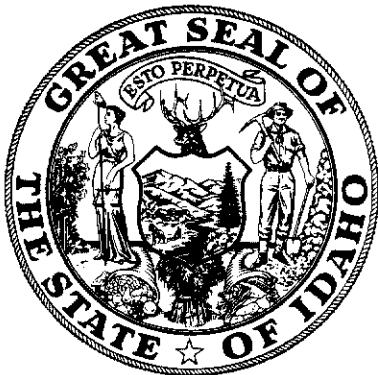

THIS IS TO CERTIFY that GUY B. DUMAIS, JACK FELGENHAUER and NORMAN R. WILSON, all being over the age of twenty-one years, for the purpose of forming a Non-Profit Corporation under the laws of the State of Idaho, do hereby certify and adopt in duplicate the following ARTICLES OF INCORPORATION:

ARTICLE I.

The name of this corporation shall be WOODLAND PARK, INC. and it shall be a Non-Profit Corporation under the Laws of the State of Idaho.

ARTICLE II.

The existence of this corporation shall be perpetual.

ARTICLE III.

The purposes for which this corporation is formed is the ownership, maintenance, operation and control of common areas in Woodland Shores First Addition in Kootenai County, Idaho.

ARTICLE IV.

Membership in the corporation will be mandatory with each owner of a platted lot in Woodland Shores First Addition. Optional membership in this corporation shall be available to purchasers of platted lots in subsequent subdivisions in Government Lot 4


