## ARTICLES OF INCORPORATION

0F

## PANHANDLE TRUSTEE SERVICES, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation.

## ARTICLE I

The name of this corporation shall be PANHANDLE TRUSTEE SERVICES, INC..

#### ARTICLE II

The period of existence and duration of the life of this corporation shall be perpetual.

### ARTICLE III

This corporation is organized for the purpose of the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, including serving as a Trustee in Bankruptcy under Title II, Chapter 5, United States Code.

### ARTICLE IV

The total number of shares of the corporation shall consist of 50,000 shares of Common Stock having a par value of One (\$1.00) Dollar per share for a total value in stock

of Fifty Thousand (\$50,000.00) Dollars, all of one class denoted Common Stock, each share being entitled to one (1) vote.

#### ARTICLE V.

There are no provisions denying preemptive rights.

#### ARTICLE VI

Provisions for the regulation of the internal affairs of the corporation are to be set forth in the By-Laws of the corporation.

#### ARTICLE VII

The address of the initial registered office of the corporation is 123 South Third, Sandpoint, Idaho, and the name of the initial registered agent at such address is Ford Elsaesser.
