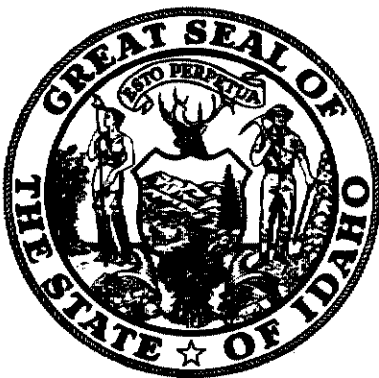

The undersigned incorporators, desiring to form a corporation pursuant to the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE. The name of the corporation is Feed Service, Inc.

ARTICLE TWO. The purpose of the corporation is to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE THREE. The period of duration of the corporation is perpetual.

ARTICLE FOUR. The address of the corporation's initial registered office in the State of Idaho is 511 South Kimball, Caldwell, Idaho 83605. The name of the corporation's initial registered agent at such address is Perry Morris Brock.

ARTICLE FIVE. The total authorized number of shares is 100, which shares are no par.

ARTICLE SIX. There are no special provisions denying preemptive rights and shareholder preemptive rights shall be determined in accordance with Section 30-1-26, Idaho Code.

ARTICLE SEVEN. To the extent permitted by law, the Corporation is authorized to repurchase its own shares and, when so doing, may utilize both unreserved and unrestricted earned surplus and unreserved and unrestricted capital surplus and

common and preferred capital and paid in capital.

ARTICLE EIGHT. The number of Directors constituting the initial Board of Directors of the Corporation is two (2) and the names and addresses of the persons who are to serve as Directors until the first annual meeting of Shareholders or until their successors are elected and shall qualify are:
