


Straight Street Ministries, Inc. will have members. It's charter members are the individuals described above in paragraph C.

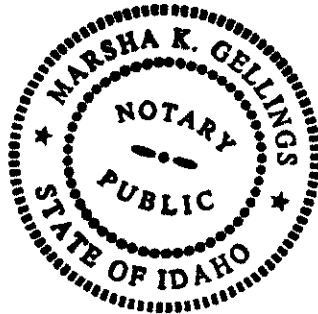
