The undersigned, being all of the Shareholders and Officers of Avcenter, Inc., an Idaho business corporation, hereby unanimously adopt the following Restated Articles of Incorporation for such corporation pursuant to Idaho Code § 30-1-1007:

- **NAME:** The name of the corporation is Avcenter, Inc. 1.
- 2. **DURATION:** The period of its duration is perpetual.
- 3. **PROFIT:** This is a for profit corporation.
- 4. **PURPOSES:** The purpose or purposes for which the corporation is organized is to provide general aviation services and do all things incidental thereto and for the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, as the same from time to time shall be amended.
- 5. **SHARES AUTHORIZED:** The aggregate number of shares which the corporation shall have authority to issue is 5,000 shares of no par value common stock.
- 6. **PRE-EMPTIVE RIGHTS:** Shareholders shall have pre-emptive rights to acquire unissued or treasury stock or securities convertible into or carrying a right to subscribe to or acquire shares.
- 7. **BUSINESS AFFAIRS:** Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the corporation's By Laws, including restrictions on the transfer of shares and fixing greater quorum or voting requirements for Shareholder action than IDAHO SECRETARY OF STATE required by the Idaho Business Corporation Act.
