

ARTICLES OF INCORPORATION OF THE PAYETTE  
CONGREGATIONAL CHURCH.

Know all men by these Presents;

That we the undersigned have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the State of Idaho, and we hereby certify;

- I. The name of said Corporation is the Payette Congregational Church.
- II. The purpose for which said Corporation is formed is the carrying on and conducting public worship, and the benevolent purposes connected therewith, according to the tenets of the religious denomination known as "the Congregational Church," also to acquire, hold and use all such real estate and other property as may be reasonably necessary for the purpose of carrying into effect the objects hereinbefore mentioned.
- III. The place where the principal business of said Corporation is to be transacted is Payette, Ada County, Idaho.
- IV. The time for which it is to exist is *Fifty years* from and after date of the incorporation.
- V. The Trustees having the control and management of the business of said Corporation are three in number, and their names and residences, and the terms of office for which said Trustees were elected, are as follows, to wit:

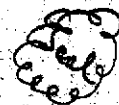
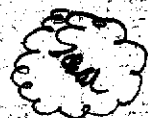
