<u>FIRST</u>

The name of the corporation is and shall be D & B Ag., Inc.

SECOND

The purpose of the corporation is as follows:

To engage in all types of lawful business activity.

To engage in farming.

To deal in stocks, bonds, or other securities, investments including the purchase and sale of the same, and in particular to purchase and sell, deal in or trade stocks issued by this corporation, and to acquire its own stock in such a manner and upon such terms and conditions as the Board of Directors may determine to be in the best interest of the corporation.


