The unity of state adopted to the incorporator of the above corporation ("Corporation") organized pursuant to and subject to the Idaho Nonprofit Corporation Act; Chapter 30, Title 30, Idaho Code ("Act"), adopts the following Articles of Incorporation for the Corporation.

ARTICLE I. NAME

The name of the Corporation is <u>Canyon County Deputies</u>' Association, Inc.

ARTICLE II. NONPROFIT STATUS

The Corporation is a nonprofit corporation.

ARTICLE III. PERIOD OF DURATION

The period of duration of the Corporation is perpetual.

ARTICLE IV. PURPOSES

The Corporation is organized to promote the social welfare of Canyon County, Idaho, through the advancement of professional qualities, ethics, and standards for employees of the Canyon County Sheriff's Office, including supporting the general public's wellbeing, by:

- 1) Encouraging the advancement of law enforcement skills, law enforcement training, and professional standards of Canyon County law enforcement.
- 2) Increasing the general public's recognition of Canyon County Sheriff employees' professional abilities and the public perception that the Canyon County Sheriff employees are able to provide safety in their community.
- 3) Promoting relationships between Canyon County Sheriff employees and their employer in order to increase the effectiveness of law enforcement in Canyon County.
- 4) Promoting relationships between law enforcement and the general public in order to increase the trust between the general public and law enforcement. This trust also creates more effective law enforcement and safer communities.
- 5) Promoting events that allow Canyon County Sheriff employees the opportunity to interact with the general public outside of law enforcement duties in order to build trust in Canyon County law enforcement.
- 6) Promoting events that allow Canyon County Sheriff employees the opportunity to promote public wellbeing through charitable, educational, and recreation activities.

7) To exercise all powers granted by law necessary and proper to carry out the foregoing purposes, including but not limited to, the power to accept donations of money, property, whether real or personal, or any other things of value. Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Act, or any amendment thereto or substitute therefore, may not at that time lawfully carry on or do.

ARTICLE V. LIMITATIONS

No part of the net earnings of the Corporation shall inure to the benefit of its members, directors, officers, or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.

Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(4) of the Internal Revenue Code of 1986, as amended from time to time.

ARTICLE VI. REGISTERED OFFICE AND AGENT

The address of the initial registered office of the Corporation is <u>P.O. Box 1084, 107 S. Kimball, Ste. 205, Caldwell, Idaho 83606</u>, and the name of its initial registered agent at that office is Shawn C. Maybon.

ARTICLE VII. MEMBERS

The Corporation shall have voting members. The characterizations, qualifications, rights, limitations, and/or obligations attaching to each class of membership shall be described within the Corporation's Bylaws.

ARTICLE VIII. BOARD OF DIRECTORS

The number of Directors of the Corporation shall be as specified in the Bylaws. The following shall serve until the first annual meeting of the members and until successors shall have been elected and qualified:
