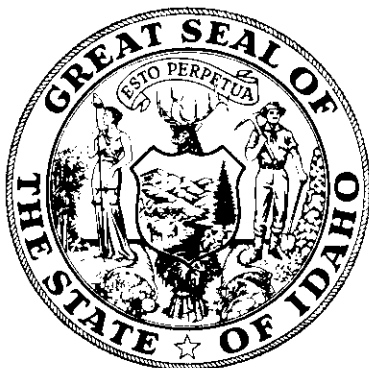

KNOW ALL BY THESE PRESENTS:

The undersigned, acting as an incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation is GWJ, INC.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the corporation is organized are: To carry on and conduct the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV.

The aggregate number of shares which the corporation shall have authority to issue is TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00), which shall be divided into Two Hundred Fifty (250) shares of common stock, the par value of each share shall be One Hundred Dollars (\$100.00), and such stock shall be nonassessable.

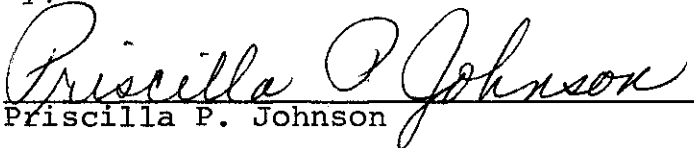

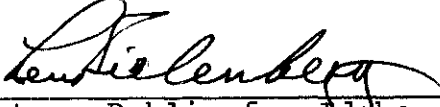
