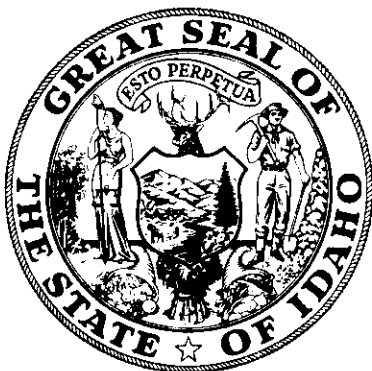

ARTICLES OF INCORPORATION

OF

IDAHO FAIR SHARE, INC.

- ARTICLE I: The name of the corporation is: IDAHO FAIR SHARE, INC.
- ARTICLE II: The period of duration is perpetual.
- ARTICLE III: The purpose for which the corporation is organized is to secure greater economic and social justice for the people of Idaho through education, research, and through working with people at the neighborhood and state-wide level on problems directly affecting their lives. The corporation may engage in any lawful activity, none of which is for profit, for which corporations may be organized under Title 30, Chapter 3, of the Idaho Code.
- ARTICLE IV: This Corporation is not organized, nor shall it be operated, for pecuniary gain or profit, and does not contemplate the distribution of gains, profits or dividends to its members or to any private individual. The property, assets, profits, and net income of this Corporation are irrevocably dedicated as set forth in Article III, and no part of the profit or net income of this Corporation shall ever inure to the benefit of any private shareholder or individual, except this provision shall not be construed to prevent the payment to directors, officers or employees of reasonable compensation for services actually rendered the Corporation. Upon dissolution or winding up this Corporation, the assets of this Corporation remaining after payment of, or provisions for payment of, all debts and liabilities of this Corporation, shall be distributed to a non-profit corporation, fund or foundation organized for purposes consistent with those of Idaho Fair Share.
- ARTICLE V: The address of the initial registered office is: 216 N. 8th, Room 604, Boise, ID 83702, and the name of its initial registered agent at such address is: Al Fothergill.
- ARTICLE VI: The number of Directors constituting the initial Board of Directors of the Corporation is 18, and the names and addresses of the persons who are to serve as directors until the first annual meeting or until their successors are elected and shall qualify are:


