The undersigned natural persons, each more than eighteen (18) years of age, hereby establish a professional service corporation pursuant to the statues of Idaho, and adopt the following Articles of Incorporation:

1. NAME. The name of the corporation is **Id Hi-Tech Organic Refrigerant, INC.**

2. DURATION. The Corporation shall have perpetual existence.

3. PURPOSE AND POWERS. To carry on the business of exercising, performing, developing, producing, obtaining, promoting, selling and distributing rights, service, goods, wares, and merchandise of all kinds, including but not by way of limitation, those in the chemical, mineral, pharmaceutical, biological, medicinal, industries.

4. QUALIFICATIONS OF SHARHOLDS. Shares to be owned and voted by the named incorporation

5. AUTHORIZED SHARES. The aggregated number of shares which the Corporation shall have authority to issue is 1,000 common shares, each being without par value.

6. VOTING. Each shareholder of record shall have one vote for each share of stock standing in his name on the books of the Corporation. Cumulative voting for the election of directors

is permitted.

7. PURCHASE OR TRANSFERS UPON INELIGIBILITY. Within 30 days after any shareholder ceases to be eligible to be a shareholder, the Corporation shall purchase all of the shares he owns or such shares shall be transferred to a qualified person as described in Article 4. The price to be paid by the Corporation and the schedule of payments shall be as specified in the By Laws, and if no price or schedule is so specified, the price shall be the pro rated net book value thereof as of the last day of the month preceding the date of purchase and payment shall be made in cash against receipt of the shares.

8. INITIAL DIRECTORS. Two directors shall constitute the initial board, their names and addresses being as follows:

9. MANAGEMENT OF CORPORATION. The business and affairs of the Corporation shall be managed by the shareholders of the Corporation and the Board of Directors.

The Board shall be authorized to manage only so much of the business and affairs of the Corporation as shall from time to

time be delegated to it by the shareholders by means of By Laws or otherwise.

Only directors and officers of the Corporation who are eligible to be shareholders shall exercise any authority with respect to professional decisions and matters relating to the practice of law.

The right to amend or repeal the By Laws and to adopt new By Laws is reserved to shareholders.

10. ADDRESS. The address of the initial registered officer of the Corporation is 522 Addison Avenue West, Twin Falls, Idaho 83301. The name of its initial registered agent at such address is Mario G. Rojas, Sr.

11. SUBCHAPTER S. Whenever the Corporation shall have in effect a valid election, neither terminated nor revoked, to be taxed pursuant to Subchapter S of the Internal Revenue Code of 1954, or any amendment thereof, no attempted transfer or hypothecation, voluntary or involuntary (including any caused by the death of a shareholder), of any stock of the Corporation shall be effective unless and until the proposed transferee shall have timely executed and delivered any consent or other documents required to maintain in full force and effect such election.





