
### CERTIFICATE OF INCORPORATION OF

**ARTICLES OF INCORPORATION**  
OF **KARL R. DECKER, P.A.**

The undersigned, acting as the incorporator of a corporation under the Idaho Professional Service Corporation Act and the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

**FIRST:** The name of the corporation is:

**KARL R. DECKER, P.A.**

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purpose for which the corporation is organized is to provide professional services in the practice of law, allied professional services, and all other purposes allowed by the laws of the State of Idaho.

**FOURTH:** The aggregate number of shares which the corporation has authority to issue is fifty (50) shares of common stock, all of one class, without par value.

**FIFTH:** That the address of the initial registered office of the corporation is 501 Park Avenue, Idaho Falls, Idaho 83402, and the name of its initial registered agent at such address is Karl R. Decker.

**SIXTH:** The corporation shall have no Directors. The power to conduct and manage the corporate affairs conferred or imposed upon Directors by the Idaho Professional Service Corporation Act, Idaho Code §§1301 et seq., and the Idaho Business Corporation Act, Idaho Code §§ 30-1-1 et seq., are hereby conferred or imposed on the Shareholders.
