ARTICLES OF INCORPORATION OF

L.L.L. TRUCKING, INC.

KNOW ALL ME BY THESE PRESENTS: That we, the undersigned, being natural persons of full age and citizens of the United States, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the General Corporation Laws of the State of Idaho and the acts amendatory thereof and supplemental thereto, do hereby certify as follows:

ARTICLE I

That the name of the corporation is L. L. L. Trucking, Inc.

ARTICLE II

The corporation is to have a perpetual existence.

ARTICLE III

The purposes for which the corporation is organized are as follows:

(1) To engage in the general business of trucking and to purchase or lease trucks and equipment appropriate for the carriage of goods; to pur-

- chase, construct, sell, hire or let such vehicles, machinery and other title and things used for any of the above purposes; to enter into contracts with any person or company as to interchange of traffic, equipment, running powers or otherwise, and to obtain all powers and authorities necessary to carry out or extend any of the above objects.
- (2) To carry freight for hire; to receive and load all varieties of commercial freight on board highway motor vehicles; to transport such freight to various destinations throughout the United States, and to buy, sell, and otherwise deal in or with tractors and trailers suitable for commercial trucking, and to maintain and repair the same; and
- (3) The transaction of any or all lawful business for which corporations may be incorporated under the General Corporation Laws of the State of Idaho, or any act amendatory thereof or supplemental thereto or substituted therefore; provided, however, that nothing contained herein shall be deemed to authorize or permit the corporation to carry on any business or to exercise any power or to do any act which a corporation formed under the act hereinbefore referred to, may not at the time lawfully carry on or do.

ARTICLE IV

The corporation shall have authority to issue fifty thousand (50,000) shares, all such shares to be of one class of common stock, and are to be of a par value of One Dollar (\$1.00) each.

ARTICLE V

The private property of the stockholders of the corporation shall not be subject to the payment of corporate debts to any extent whatsoever, and the shares of the corporation shall not be subject to assessment for the purpose of paying expenses, conducting business, or paying debts of the corporation.

ARTICLE VI

The number of directors of the corporation shall be as specified in the By-Laws, and such number may from time to time be increased or decreased in such manner as may be prescribed in the By-Laws.

ARTICLE VII

Stockholders of the corporation shall have preemptive preferential rights of subscription to any shares of stock of the corporation, whether now or hereafter authorized, and any obligations issued by the corporation shall first

be offered to the stockholders of the corporation.

ARTICLE VIII

The address of the initial registered office of the corporation shall be 3920 Dorman Ave., Caldwell, ID 83605, and the name of the registered agent at such address shall be Joe L. Lynde.

ARTICLE IX

The number of directors constituting the initial Board of Directors shall be two (2) , and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders, or until their successor or successors shall be elected and qualify shall be as follows:
