ARTICLE I

The name of this corporation is: **ASLAN CHRISTIAN ACADEMY , Inc.**

ARTICLE II

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes. The corporation is organized exclusively for charitable and educational purposes, more specifically to provide food, clothing, boarding and trauma care services, medical, eye care, and dental services, and, to provide for an accredited education including entrepreneurnial training for young and adolescent women between the ages of 10 through 17 who are rescued victims of commercial sexual exploitation and physical abuse. With the help of GOD throughout their leadership training and experiences, they will be able to make a positive contribution to their society. To this end, the corporation shall at all times be operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the internal revenue code of 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contributions or otherwise, shall be devoted to said purposes.


ARTICLE VII

ARTICLE VIII


