ARTICLES OF INCORPORATION

OF

HAMMONS BROS. LOGGING, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is HAMMONS BROS. LOGGING, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is logging and to conduct the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate amount of shares which the corporation shall have the authority to issue is Fifty Thousand (50,000), all of one class, One Dollar (\$1.00) par value.

FIFTH: Provisions denying preemptive rights are: NONE.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: NONE

SEVENTH: The address of the initial registered office of the corporation is P. O. Box 220, Fernwood, Idaho 83830, (Highway 3, Route 4, Fernwood, Idaho 83830), and the name of its initial registered agent at such address is ROBERT CARL HAMMONS, JR.
