### SECOND AMENDMENT TO PARTNERSHIP AGREEMENT

#### ROKAN PARTNERS

The Partnership Agreement of Rokan Partners is amended as hereinafter set forth.

This amendment amends the document dated June 28, 1990 which is entitled "Restated Agreement of Limited Partnership of Rokan partners, a California Limited Partnership" and that document dated December 31, 1993 entitled "Amendment to Partnership Agreement Rokan Partners".
