#### AMENDMENT TO

### ARTICLES OF INCORPORATION

OF

#### FOOD PRODUCERS OF IDAHO, INC.

WHEREAS, At a meeting of the members of the above named corporation, duly and regularly called and held at <a href="Holiday Inn">Holiday Inn</a>, <a href="Holiday Inn">11:30 o'clock A.M.</a>, the <a href="Holiday of July">16th</a> day of July</a>, 1973, at the principal office of the corporation in the City of Boise, Ada County, Idaho, at which there were present and voting in person, or by proxy, two-thirds of the membership of the said corporation. There was presented and adopted by unanimous vote the following resolution, amending the Articles of Incorporation of said corporation, to-wit:

"RESOLVED, That the Articles of Incorporation of Food Producers of Idaho, Inc., be amended to add an additional paragraph to said Articles of Incorporation denominated as Article XIII and to read as follows."

## ARTICLE XIII

This corporation is organized for the use and benefit of its members and not for the purpose of direct gain to the corporation itself, the purpose of this corporation being a non-profit corporation under the provisions of Section 30-117A of the Idaho Code, and no firm, person, association, corporation or commission shall become a member of this corporation unless and until it shall have been approved for such membership by a majority vote of the directors present at a regular or special meeting of the Board of Directors. There shall be three forms of membership:

- 1. Regular active voting membership, which shall be known as participating membership;
- Supporting, non-voting membership;
- Associate, non-voting membership;

the dues for each classification to be determined by the Board of Directors. Voting rights shall be extended only to those participating members whose membership dues are paid in full."

NOW, THEREFORE, We, the President and Secretary of Food

Producers of Idaho, Inc., being duly authorized by the resolution aforesaid, do hereby execute this amendment of the Articles of Incorporation,

adding Article XIII to the original Articles of Incorporation of this corporation to read as follows:

## "ARTICLE XIII
