ARTICLES OF AMENDMENT TO RECEIVED ARTICLES OF INCORPORATION SEC. OF STATE OF 85 AUG 29 AM .9 02

Articles of Amendment of the Articles of Incorporation of C & R PLUMBING & HEATING, INC., are herein executed by said Corporation, pursuant to the provisions of Section 30-1-59, et seq., of the Idaho Business Corporation Act, as follows:

- 1. The name of the Corporation is C & R PLUMBING & HEATING, INC.
- 2. The amendments to the Articles of Incorporation of said Corporation are as follows:
 - A. ARTICLE III shall be amended to read as follows:

"III.

The duration of this Corporation shall be perpetual."

B. ARTICLE IV shall be amended to read as follows:

"IV.

The location of this Corporation shall be, and the post office address and registered office in the state of Idaho shall be 6424 N. Government Way, Coeur d'Alene, Idaho 83814. The registered agent at that address shall be Donald K. Rude."

C. There shall be added an Article IX which shall read as follows:

"IX.

Shareholders of this Corporation shall have preemptive rights to acquire additional shares offered for sale by the Corporation."

D. There shall be added an Article X which shall read as follows:

"Χ.

The Corporation shall have the right to purchase its own shares from the unreserved and unrestricted capital surplus available, as well as from the unreserved and unrestricted earned surplus available."

- 3. The date of the adoption of said amendment by the shareholders of the Corporation is August 3, 1985.
- 4. The number of shares outstanding of Corporation is one hundred nineteen and seventy-nine/one-hundredths (119.79) shares, all of which are entitled to vote.
- 5. The number of shares voting for and against said amendment, respectively, were as follows:

- 6. The amendment does not provide for the exchange, reclassification, or cancellation of issued shares.
- 7. The amendment does not effect a change in the amount of the Corporation's stated capital.
