I, the undersigned, being an adult citizem PREC 16 AM 10 18 the united States of America, do hereby form a corporation pursuant to Chapter 1 of Title 30, Idaho Code, and so hereby adopt and certify the following Articles of Incorporation, to-wit:

ARTICLE I

The name of this Corporation shall be MARJAN'S BOOKKEEPING & TAX SERVICE INC.

ARTICLE II

The term of existence of this corporation shall be perpetual.

ARTICLE III

The purposes for which this corporation is organized are the transactions of any and all lawful businesses for which corporations may be incorporated under this act.
