ARTICLES OF INCORPORATION

OF

RUTLEDGE BROTHERS, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of full age and citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of the State of Idaho, do hereby certify as follows:

ARTICLE I.

That the name of the corporation shall be: "RUTLEDGE BROTHERS, INC."

ARTICLE II.

That the purposes for which said corporation shall be formed are:

- a. To conduct and carry on the business of builders, contractors and merchants, for the purpose of building, fabricating, manufacturing, erecting, repairing, altering, demolishing, applying, installing, buying, selling, brokering and generally dealing in buildings, structures, building materials, hardware, miscellaneous appliances, equipment, fixtures, paving, roofing, electrical appliances, steel and all other metals, lumber, timber, insulation, plumbing and electrical supplies and equipment, and doing any other work in connection with any and all classes of building, structures, and improvements of every kind and nature whatsoever in all classes of buildings, structures and improvements both public and private or integral parts thereof or equipment therefor.
- b. To purchase, or otherwise acquire, own, hold, lease, sell, exchange, assign, transfer, mortgage, hypothecate, pledge

or otherwise dispose of, to guarantee, and to invest, trade and deal in and with personal property of every class and description.

- c. To purchase, or otherwise acquire, own, hold, lease, sell, exchange, assign, transfer, mortgage, hypothecate or otherwise dispose of, and to invest, trade and deal in and with real property and any and all interests therein.
- d. To enter into any kind of contract or agreement, bonus or profit-sharing plan with its officers and employees that the corporation may deem advantageous or expedient, or otherwise to reward or pay such persons for their services as the directors may deem fitting.
- e. To purchase, lease, or otherwise acquire, in whole or in part, the business, good will, rights, franchises and property of every kind, and to undertake the whole or any part of the assets or liabilities of any person, firm, association, partnership or corporation engaged in or authorized to conduct any business similar to any business authorized to be conducted by this corporation, or owning property necessary or suitable for its purposes, and to pay for the same in cash, in stock of this corporation, or otherwise; to hold or in any manner dispose of the whole or any part of the business or property so acquired; and to exercise all the powers necessary or incidental to the conduct of such business.
- f. To borrow money, to issue bonds, debentures, notes and other obligations of this corporation from time to time, for any of the objects or purposes of this corporation, and to mortgage, pledge, hypothecate or convey in trust any or all of the property of the corporation to secure the payment thereof.
- g. To enter into, make, perform and carry out contracts of every kind and for any lawful purpose, without limit as to

amount, with any person, firm, association, corporation, state, municipality, government, or any subdivision, district, department, agency or instrumentality thereof.

- h. To acquire and pay for in cash, shares of stock or notes of this corporation or otherwise, the assets, including the good will, of any person, firm, partnership, association or corporation, and to undertake or assume the whole or any part of the obligations or liabilities thereof.
- i. To do any and all such other acts, things, business or businesses in any manner connected with or necessary, incidental, convenient or auxiliary to any of the objects hereinbefore enumerated or calculated, directly or indirectly, to promote the interest of the corporation; and in carrying on its purposes or for the purpose of attaining or furthering any of its business, to do any and all acts and things, and to exercise any and all other powers which a natural person could do or exercise and which now or hereafter may be authorized by law, and in any geographical location.
- j. The several clauses contained in this statement of purposes shall be construed as both purposes and powers, and the statements contained in each clause shall be in no wise limited or restricted by reference to, or inference from, the terms of any other clause, but shall be regarded as independent purposes and powers; and no recitation, expression or declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive; but it is hereby declared that all other lawful powers not inconsistent herewith are hereby included.

ARTICLE III.

That the location and post office address of the registered office and principal place of business of this corporation shall be Boise City, Ada County, Idaho

ARTICLE IV.

That the period of existence and duration of life of this Articles of Incorporation, P. 3

corporation shall be perpetual.

ARTICLE V.

That the total number of shares of stock which this corporation shall have authority to issue is One Thousand (1,000) shares, all of the same class and with equal rights and participation, and each such share of stock shall be of the par value of \$100.00, making a total authorized capitalization of One Hundred Thousand and no/100 (\$100,000.00) Dollars. Said stock shall not be subject to assessment.

ARTICLE VI.

The number of directors of this corporation shall be three (3).

ARTICLE VII.

That the names and addresses of the persons who are appointed to act as the first directors of this corporation are <u>J. L.</u>

<u>fulleoff</u>, <u>Clyofv. Aufleoff</u> and <u>J.W. Aufleoff</u>, all of Boise, Idaho, and they are to hold office as such directors until and unless other directors are elected and qualify as their successors.

ARTICLE IX.

The Board of Directors of the corporation shall have the power to adopt, amend and repeal the By-Laws of the corporation.

This corporation reserves the right to at any time amend, alter, change or repeal any provisions contained in this certificate in the manner now or hereafter prescribed by the statutes of the State of Idaho, and all rights conferred upon stockholders herein are granted subject to this reservation.
