ARTICLES OF AMENDMENT OF INCORPORATION

OF

RIRIE SENIOR CITIZENS, INC.

These Articles of Amendment amend those certain Articles of Incorporation for Ririe Senior Citizens, Inc., dated the 28th day of December, 1978.

ARTICLE I

- A. The name of the Corporation shall continue to be Ririe Senior Citizens, Inc.
- B. Article II, Article VIII and Article IX shall be deleted. In lieu thereof, Article II shall read:

This organization is organized exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

"Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law)."

"Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assests shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious and/or scientific purposes and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code."

The amendment set forth above was adopted at a meeting of members on the 17th day of May, 1988, a quorum was present at such

meeting and such amendment was received by at least a majority of the votes of the members present at such meeting in person or by proxy.
