

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is HARRISON AUTOMOTIVE GROUP, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes of the Corporation shall be to manufacture, buy, sell, lease, trade, repair, alter and otherwise deal in motors, automobiles, trucks, cars and other vehicles, their parts, accessories and related articles and generally to conduct an automobile and truck dealership business in all its aspects and, further authorize the sale of insurance.
