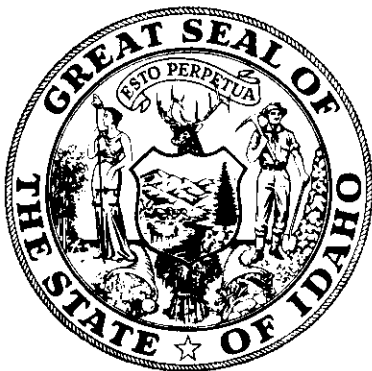

ARTICLES OF INCORPORATION

OF

R-VALUE, INC.

WE, THE UNDERSIGNED, natural persons of the age of eighteen years or more, acting as incorporators of a corporation under Title 30, Chapter 1, Idaho Code, Idaho Business Corporation Act, hereby adopt the following Certificate of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation is R-Value, Inc.

ARTICLE II

Term of Existence

The period during which the corporation shall continue is perpetual.

ARTICLE III

Purpose

The purposes for which the corporation is formed are: To engage in manufacturing, wholesaling, retailing and installation of weatherization measures and related equipment, and the transaction of any and all lawful business for which corporations may be incorporated under this Act.

ARTICLE IV

The corporation shall have three (3) directors. The original board of directors shall consist of the following named individuals:

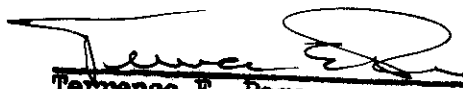

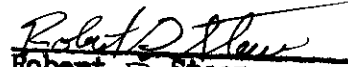
