- (ii) An intentional infliction of harm on the corporation or the shareholders;
- (iii) A violation of section 30-29-833, Idaho Code; or
- (iv) An intentional violation of criminal law; and

The Corporation shall indemnify a director for liability as defined in I.C. § 30-29-850(5),

Idaho Code to any person for any action taken or not taken as a director except:

- (i) Receipt of a financial benefit to which he is not entitled;
- (ii) An intentional infliction of harm on the corporation or its shareholders;
- (iii) A violation of section 30-29-833, Idaho Code; or
- (iv) An intentional violation of criminal law.
