# ARTICLES OF INCORPORATION OF SYRINGA GIRLS STATE, INC.

know all Men By These Presents: That we, the undersigned, being of full age and citizens of the United States of America, and residents of Latah, Clark, Jerome, Ada, Canyon, Nez Perce, Bonneville, and Bonner counties, respectively, of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation under title 30, Chapter 10, Idaho Code, and hereby certify:

#### ARTICLE I.

That the name of the corporation shall be "SYRINGA GIRLS STATE, INC."

#### ARTICLE II.

That the principal place of business of this corporation shall be Boise, Ada County, Idaho.

#### ARTICLE III.

The life of the association shall be Fifty (50) years.

ARTICLE IV.

(a) To give to the girls throughout the state who shall have completed their third year's work in high school and who shall have been duly selected as delegates to GIRLS STATE, a brief course in practical government; to stress the duties, privileges, rights and responsibilities of American citizenship; to teach constructive attitudes toward American government and to give them a clearer insight into the advantages our republican form of government has over totalitarian states and to show that our system has not outworn its usefulness; to instill in them a desire to become increasingly better informed and more responsible and worthy citizens; to inculcate a greater appreciation of our heritage of freedom and our American way of life.

(a) to combat the menace of Communism and other subversive forces through the building up of a knowledge of our nation's

glorious history; to stress unity, loyalty, faith and strength rather than disunity, disloyalty, distrust and weakness; courage and honor and honesty in the administration of our government rather than appeasement, dishonesty and moral cowardice.

- (c) To conduct annual meetings for said girls that shall be known as "SYRINGA GERLS STATE"; that said meetings shall be held in Idaho where adequate facilities are available.
- (d) To enter into and perform any necessary contracts; to do everything proper for the accomplishment of its objects.

#### ARTICLE V.

The number of persons who may become members shall be limited to those who are paid-up members of the American Legion Auxiliary of the Department of Idaho, and the Board of Directors shall fix the dues and assessments; their rights shall be equal.
