**STATEMENT OF MERGER
OF
PAVESTONE CAPITAL LLC,

The undersigned, on behalf of each of the limited liability companies set forth below, pursuant to Title 30, Chapter 22, Part 205 of the Idaho Model Entity Transactions Act, state as follows:

1. The names of the parties to the merger are as follows:

FleetOne Factoring, LLC, a Tennessee limited liability company (the “Surviving Subsidiary”); and

Pavestone Capital LLC, an Idaho limited liability company and wholly-owned subsidiary of the Surviving Subsidiary (the “Merging Subsidiary”).
2. The merger will be effective as of 10:59pm Mountain Time on the date this Statement of Merger is filed with the Secretary of State pursuant to Section 30-22-205(f) of the Idaho Model Entity Transactions Act.
3. A resolution approving the merger and the plan of merger was duly approved by the sole member (who is also the managing member) of the Surviving Subsidiary and the managers and sole member of the Merging Subsidiary on January 12, 2022, as required by the articles of organization, the operating agreements and the laws of the jurisdiction of each of the Surviving Subsidiary’s and Merging Subsidiary’s formation.
4. Since the Surviving Subsidiary is a foreign entity that is not a registered foreign entity, the undersigned entities submit the following statement for the purpose of designating a registered agent in accordance with Section 30-21-411 of the Idaho Code:
 1. The name of the entity is: FleetOne Factoring, LLC.
 2. Immediately following the merger, FleetOne Factoring, LLC shall amend its articles of organization to change its name to “WEX Capital LLC”.
