Pursuant to the Idaho Business Corporation Code, the following Articles of Amendment to the Articles of Incorporation of Airport Investments, Inc. are adopted by all shareholders of the corporation:

FIRST: The name of the corporation is Airport Investments, Inc.

SECOND: The following amendment to the Articles of Incorporation was adopted on the 16th day of SEPTEMBER, 1996.


Article I was amended to change the name of the corporation to Airport Chevron, Inc..


THIRD: The number of shares of common stock of the corporation outstanding at the time of the amendment was 999 and the number of shares entitled to vote on the amendment was 999.
