ARTICLES OF INCORPORATION

OF

PINKSTON CORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation, to-wit:

Article One

The name of the corporation is PINKSTON CORPORATION.

Article Two

The corporation is a perpetual entity.

Article Three

The purposes for which the corporation is organized are all lawful activities for which corporations may be incorporated under the Idaho Business Corporation Act.

Article Four

The aggregate number of shares which the corporation shall have the authority to issue is One Hundred Thousand (100,000) shares having no par value. Said shares shall not be issued until fully paid.

Article Five

The private property of the stockholders of the corporation shall not be subject to the payment of corporate debts to any extent whatsoever, and the shares of the corporation shall not be subject to assessment for the purposes of paying expenses, conducting business, or paying the debts of this corporation.

Article Six

The number of directors of the corporation shall be as specified in the bylaws of the corporation, and any such number may from time to time be increased or decreased in such a manner as may be prescribed in the bylaws and in accordance with the Idaho Business Corporation Act. The number of directors constituting the initial board of directors is one (1), and the name and address of the person who is to serve as the director until the first annual meeting of shareholders, or until his successor is elected and qualified, are as follows:

Article Seven

The initial bylaws shall be adopted by the board of directors and shall control the internal affairs of the corporation. The power to alter, amend or repeal the bylaws or to adopt new bylaws shall be vested in the board of directors. Such power may be exercised by a majority vote of the board of directors at any annual or special meeting of the board of directors called for that purpose, or by resolution of the directors in accordance with law.

These Articles of Incorporation may be amended by a majority vote at any annual or special meeting of shareholders, either upon consideration of a resolution for amendment adopted by the board of directors, or upon consideration of a resolution adopted by the holders of not less than fifty-one percent (51%) of all shares entitled to vote at such a meeting.

Article Eight

Shareholders' pre-emptive rights are not to be limited except to the extent that the same are altered by an amendment to these Articles of Incorporation, according to the bylaws and Idaho law.

Article Nine

The address of the initial registered office of the corporation is 4856 Anderson Way, Nampa, Idaho 83687, and the name of the initial registered agent of the corporation who may be found at that address is Delmer L. Pinkston.
