Article II should be amended to read as follows:

ARTICLE II

The objects and purposes of which this corporation is formed and the powers of such corporation is as follows:

- (1) To do all acts necessary and convenient to carry on a nonprofit and religious enterprise and for the exclusive purpose of doing charitable, religious, and other good works as may be described by Section 501(c) (3) of the Internal Revenue Code. The corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code.
- (2) To do all such acts, including engaging in the sale, purchase, investment, and financing of real and personal property, and the leasing, apothecating, transferring, mortgaging, assigning, or any way dealing with property in accordance with the laws relating to nonprofit, charitable, and religious corporations and to do such other acts as may be permitted by the law of the State of Idaho, relating to nonprofit, charitable, and religious organizations.

Article VII should be amended to read as follows:

ARTICLE VII

The Board of Trustees shall have power by majority vote thereof to acquire and hold title to real and personal property and to make, execute and deliver Bills of Sale, Deeds and Conveyances for the sale and conveyance of the same. Said Board of Trustees shall have power by majority vote thereof, to make, execute and deliver promissory notes, either unsecured or secured by mortgages or deeds of trust upon the real or personal property of the

Corporation. The Board of Trustees shall have authority by majority vote thereof to expend any moneys or funds of the corporation for the acquisitions or maintenance of the property or the corporation.

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation which has established its tax exempt status under Section 501(c) (3) of the Internal Revenue Code.

WE the undersigned, being respectively the President of the Board of Trustees and the secretary of the 901 Albany Church of Christ, Inc., a corporation, do hereby certify that the foregoing Amendments to the Articles of Incorporation were adopted as such on March 16, 1986 by a majority vote of the members of the corporation. A quorum was present at that meeting.
