ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF  
ODEN MOTOR, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporations Act, the undersigned corporation, Oden Motor, Inc., adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The following Amendment to Articles of Incorporation was adopted by the Shareholders of the corporation on the 19th day of November, 1987, in the manner described by the Idaho Business Corporation Act:

ARTICLE I shall be amended to read as follows:

ARTICLE I

The name of the corporation shall be PAINT YOUR WAGON, INC.

SECOND: The number of shares of the corporation outstanding at the time of the adoption of said Amendment was one hundred (100) and the shares entitled to vote thereon were one hundred (100).

THIRD: The number of shares voted for such Amendment was one hundred (100) and the number of shares voted against such Amendment was zero (0).

FOURTH: The Amendment does not effect any change, reclassification or cancellation of issued shares and does not affect or change the amount of stated capital.

FIFTH: The original Articles of Incorporation of the corporation are confirmed in all other respects.
