



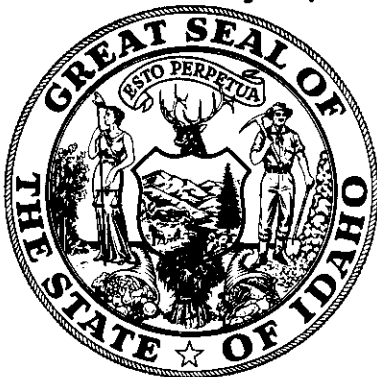
CERTIFICATE OF INCORPORATION

The undersigned, Beauty For All Seasons, Inc., an Idaho corporation, acting as the incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is: BEAUTY FOR ALL SEASONS INTERNATIONAL, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 5,000 with no par value.

FIFTH: Provisions for the regulation of the internal affairs of the corporation are as provided in the by-laws and as said by-laws may be from time to time amended.

SIXTH: The address of the initial registered office of the corporation is 360 "B" Street, Idaho Falls, Bonneville County, Idaho, and the name of its initial registered agent at such address is Wayne Virgin.

SEVENTH: The number of directors constituting the initial board of directors of the corporation is five (5), and the directors are Wayne Virgin, Norma Virgin, Verla Ball, Allen Ball and Debra Adams,, at the said address of 360 "B" Street, Idaho Falls, Bonneville County, Idaho, who shall serve as such directors until the first annual meeting of the shareholders or until their successors and/or any additional directors are elected and qualify.
